



Call of the Sea's Educational Programs

- Seaward is U.S. Coast Guard approved to carry 40 passengers within the Bay. This number does not include crew. Seaward has 12 passenger berths for overnight programs.
- Matthew Turner is U.S. Coast Guard approved to carry 65 passengers within the Bay. This number does not include crew. Matthew Turner has 19 passenger berths for overnight programs.

Bay Explorations 3-hour educational program:

- \$1750 for up to 40 passengers (students and adults)
- \$3,500 for up to 65 passengers (students and adults)

Pick-up/Drop-off Location: Call of the Sea's vessels sail from the Bay Model Pier in Sausalito. We can pick up and drop off at alternative locations within SF Bay for a \$500-\$3500 (depending on distance traveled) fee plus any additional dockage fee charged by the host marina.

Directions & Parking: Vessels are docked at the Bay Model Visitor Center, located at 2100 Bridgeway in Sausalito. Access to the dock is via Marinship Way. There is free parking in the Bay Model Visitor Centers back lot, on Marinship Way.

Scholarships: We offer need-based scholarships and discounted rates to eligible groups and individuals. Please call or email for more information.

Payment: A 50% deposit is required within 30 days of receiving the Sail Contract to confirm a reservation. The balance is required 30 days in advance of the sail date. Payment may be made in the form of money order, cashiers check, or check payable to "Call of the Sea". Credit card payment (Visa, Master Card, or American Express) incurs an additional 3.5% fee. Please request a digital invoice for credit card payment.

Weather: Programs run, rain or shine. If the Captain of the ship and CALL OF THE SEA's management decide it is safe to sail and the Organization wants to cancel, the following cancellation terms apply

Cancellation: If the sail is canceled by the Organization 30 or more days in advance, payment will be fully refunded less a \$100 administration fee. If the sail is canceled by the Organization in less than 30 days from the sail date, no payment will be refunded; however, by mutual agreement, the payment may be credited toward a future sail.

Preparing for your sail

~Please visit our website, www.CalloftheSea.org to view your options for the education program. Feel free to call the office if you have any questions about our programs or if you would like to customize your voyage.

~You will receive a call from the onboard Head Educator roughly 2 weeks prior to the sail to confirm the trip as well as exchange pertinent information about the program and passengers. Please have your program option selected and final passenger count ready by this time, as well as any information about individuals who may need special assistance. The Education Manager can be reached at education@calloffthesea.org.

~Onboard the vessel, we will separate the students into 3-5 groups depending on the programs selected. You are encouraged to make these groups ahead of time.

~Waivers are required for all passengers, youth and adults. Please bring the waivers the day of the sail.

The Day of your program

~Arrive 30 minutes before the start of your program so we can begin promptly at the scheduled time.

~Restrooms are located outside the Bay Model. We recommend students use the restroom prior to boarding. There are toilets on the ships if needed.

~We do not set aside time for lunch or snacks during 3 hour day programs. There is a picnic area at the Bay Model where the group can enjoy a snack or lunch before or after the sail.

~Gum and electronic devices (other than cameras) are not allowed on the sailing vessels.

~All passengers should wear closed-toe, flat shoes with good traction. (Sneakers are great. No sandals or high heels please!)

~Dress in warm layers. It is usually colder on the water than on land. If rain is in the forecast, please have all participants bring rain gear.

~Wear sun protection: hats, sunscreen, sunglasses

~Call of the Sea vessels always carry enough appropriately sized Type 1 PFDs for every passenger aboard and are US Coast Guard inspected every year. We require students and passengers under 13 years of age to wear a life jacket.
